4.	<p>Bill Alexander</p>	<p>For Highlands Children Planning - For Highlands Children 3 FHC3 - various strategy groups now reviewing outcomes and targets re FHC2. Scottish Government spending review showed 15 key outcomes with 45 targets behind that. Agencies will need to focus on how this complements individual corporate plans.</p> <p>Local Action Fund (LAF) Update LAF funding allocated to 22 wards not the 8 areas as previous. Any recommendations should come through this group but this isn't happening at the moment. Margaret is meeting with Mags Duncan Stirling (CLLS, HC), Graeme Cooper (NCH) and Arthur Scot (YAT,SWS) to discuss ensuring best value and collaboration is maintained.</p> <p>Consultation of organisation of Disability Services The re-organisation of HC Children's services to be completed by January 2008. The SWS specialist Central Highland Team (CHT) which includes specialist nurses was established 2 years ago. CHT is under managed at the moment and additional management put in for now. If it is extended then some of the current resource would need to go to management and not service.</p>	<p>SMG invited to a seminar 18th January at Town House, Inverness.</p> <p>Mags Duncan Stirling to be invited to January ICSMG to discuss LAF.</p> <p>Marlyn Campbell to be invited to next meeting.</p>

	<p>Do we wish to keep disability service? If it is an effective model should it be extended Highland wide? A questionnaire has been sent out with information regarding a consultation day in Inverness. Members asked to note this and ensure it has a wide circulation.</p> <p>GIRFEC Update - Bill Alexander & Sandie Young Everyone must understand the GIRFEC structures by early 2008. Lead professional training was delayed but dates out now and filling quickly.</p> <p>Services threshold (Benchmarks) Meeting was set for Thursday 29/11/07 but was cancelled due to illness. Need to have benchmarks established for early 2008. Our staff need to make sense of resources, services should be available regardless of location, and SMG will need to look at funding sources and ownership of posts. Not such an immediate pressure but will need further discussion.</p> <p>Liaison Groups Bill spoke about the role of Liaison Groups. The SMG must now plan what this structure looks like, its membership and geography. There was discussion whether it should be set round ASG or SW Team's. The professionals for INBS should be clear about the structure in the next 6 - 8 weeks. Various discussions round named persons and lead professionals. The 'named person' in schools will depend on size of school and age of child. The role of the SFLO's must be explicit this should be clear by January 2008.
